- 2.5. This authority is given only to act as per instructions given by me/us via the TTDS website or by any other means of documented instruction, or received by my/our adviser listed below (if applicable).
- 2.6. TTDS agrees to accept this appointment subject to its Terms and Conditions, and agrees to act and perform in said fiduciary capacity consistent with my best interests as he in his discretion deems advisable.
- 2.7. This power of attorney may be revoked by me/us in writing at any time as per the Terms and Conditions, provided any person relying on this power of attorney shall have full rights to regard it as current and in force.
